**RATE SCHEDULE 1: RESIDENTIAL SERVICE**

This Rate Schedule is applicable to firm Gas supplied at one Premises for use in approved appliances for all residential applications in single – family residences, separately metered single-family townhouses, row houses, condominiums, duplexes, and apartments, and single – metered apartment blocks with four or less apartments.

**Charges:**

<b>Basic Charge</b> per Day	\$ 0.4216
<b>Delivery Charge</b> per Gigajoule	\$ 8.469
<b>Storage and Transport Charge</b> per Gigajoule	\$ 2.255
<b>Gas Cost Recovery Charge</b> per Gigajoule <sup>1,2</sup>	\$ 1.660

**Municipal Operating Fee Charge:** A Municipal Operating Fee Charge of 3.09% of the aggregate of the above charges is payable (in addition to the above charges) if the Premises to which Gas is delivered under this Rate Schedule is located within the boundaries of an area to which BMUS pays these fees to the municipality and excluding any Customer from whom BMUS is not allowed to collect such Municipal Operating Fee. The Municipal Operating Fee charge will be calculated in accordance with the approved methodology<sup>3</sup>.

**Minimum Charge:** The Minimum Charge per month will be the Basic Charge and the Municipal Operating Fee Charge (where applicable and calculated in accordance with the approved methodology).

<sup>1</sup> The Cost of Gas is based on the calculation of 100% of a Customer’s consumption in Gigajoules, minus the greater of the percentage of the RNG Blend Service or the percentage of a Customer’s selection of RNG measured in Gigajoules, multiplied by the Cost of Gas (Commodity Cost Recovery Charge) per Gigajoule.

<sup>2</sup> The Approved RNG Blend is set at 3%.

**RATE SCHEDULE 2: SMALL COMMERCIAL SERVICE**

This Rate Schedule is applicable to Customers with a normalized annual consumption at one Premises of less than 2,000 gigajoules of firm Gas, for use in approved appliances in commercial, institutional, or small industrial operations.

**Charges:**

<b>Basic Charge</b> per Day	\$ 1.4309
<b>Delivery Charge</b> per Gigajoule	\$ 5.877
<b>Storage and Transport Charge</b> per Gigajoule	\$ 2.276
<b>Gas Cost Recovery Charge</b> per Gigajoule <sup>4,5</sup>	\$ 1.660

**Municipal Operating Fee Charge:** A Municipal Operating Fee Charge of 3.09% of the aggregate of the above charges is payable (in addition to the above charges) if the Premises to which Gas is delivered under this Rate Schedule is located within the boundaries of an area to which BMUS pays these fees to the municipality and excluding any Customer from whom BMUS is not allowed to collect such Municipal Operating Fee. The Municipal Operating Fee charge will be calculated in accordance with the approved methodology<sup>6</sup>.

**RATE SCHEDULE 3: LARGE COMMERCIAL SERVICE**

This Rate Schedule is applicable to Customers with a normalized annual consumption at one Premises of greater than 2,000 gigajoules of firm Gas, for use in approved appliances in commercial, institutional, or small industrial operations.

**Charges:**

<b>Basic Charge</b> per Day	\$ 4.3526
<b>Delivery Charge</b> per Gigajoule	\$ 5.377
<b>Storage and Transport Charge</b> per Gigajoule	\$ 2.051
<b>Gas Cost Recovery Charge</b> per Gigajoule <sup>7,8</sup>	\$ 1.660

**Municipal Operating Fee Charge:** A Municipal Operating Fee Charge of 3.09% of the aggregate of the above charges is payable (in addition to the above charges) if the Premises to which Gas is delivered under this Rate Schedule is located within the boundaries of an area to which BMUS pays these fees to the municipality and excluding any Customer from whom BMUS is not allowed to collect such Municipal Operating Fee. The Municipal Operating Fee charge will be calculated in accordance with the approved methodology<sup>9</sup>.
