

NOTICE OF APPLICATION BY: BMUS – TOBIANO WATER Proposed Interim Rates Effective July 15, 2025

Notice is hereby given that BMUS Tobiano Water (Tobiano) has made an application to the Comptroller of Water Rights for consent to the filing under the provisions of the *Water Utility Act* and the *Utilities Commission Act* of rates and charges for service. Effective July 15, 2025, through Order No. 2683, Tobiano has been granted an interim rate increase by the Comptroller of Water Rights. The interim rates are refundable with interest, subject to the final decision by the Comptroller of Water Rights.

The table below displays the proposed rates for the three years from 2025 to 2027. The existing approved rates for Tobiano are in effect until July 14, 2025. The interim rates effective July 15, 2025, will be reflected on the bill sent to customers in August 2025. BMUS is also seeking approval of its proposed rate design, effective January 1, 2026.
